INITIAL MEETING OF THE BOARD OF DIRECTORS OF THE TRUJILLO TRAIL DOMESTIC WATER IMPROVEMENT DISTRICT OF SANTA CRUZ COUNTY, ARIZONA

- 1. CALL TO ORDER AND ROLL CALL.
- 2. ELECTION OF CHAIR OF THE BOARD OF DIRECTORS. At this time, the Board may select one person from its membership to chair this and other Board meetings. A.R.S. § 48-1012 paragraph D provides: "The board of directors shall annually elect a chairperson from among its members."
- 3. SELECTION BY LOT OF BOARD MEMBER WITH TWO-YEAR TERM. Paragraph 13 of the petition for establishment of the TTDWID provides that election dates for Board members shall be the county wide general election date of each even numbered year, beginning in 2022, and terms of the applicable class of directors shall expire on December 31 following the election. The term of office of one Board member will end on December 31, 2022; and the terms of office of the remaining two Board members will end on December 31, 2024. A.R.S. § 48-1012 ("Elected Board of Directors") paragraph D provides in relevant part:

Immediately after the selection and qualification of the first directors of the board, the directors shall meet and divide themselves by lot into two classes as nearly equal in number as possible. Directors of the first class shall serve for a term of four years, and directors of the second class shall serve for a term of two years. Every director shall continue to discharge the duties of office until a successor is appointed and qualifies. Thereafter, at each regular election, one director for each expired term shall be elected and shall hold office for a term of four years, and until a successor is elected and qualifies.

- 4. IDENTIFICATION OF WHERE PUBLIC NOTICES OF TTDWID BOARD OF DIRECTORS MEETINGS WILL BE POSTED, AND CONSIDERATION AND DISCUSSION OF WHETHER TO ESTABLISH A TTDWID WEBSITE. A.R.S. § 38-431.02 ("Notice of meetings") paragraph (C) provides in relevant part:
 - A. Public notice of all meetings of public bodies shall be given as follows:
 - 3. Special districts that are formed pursuant to title 48:
 - (a) May conspicuously post a statement on their website stating where all public notices of their meetings will be posted, including the physical and electronic locations, and shall give additional public notice as is reasonable and practicable as to all meetings.
 - (b) May post all public meeting notices on their website and shall give additional public notice as is reasonable and

practicable as to all meetings. A technological problem or failure that either prevents the posting of public notices on a website or that temporarily or permanently prevents the use of all or part of the website does not preclude the holding of the meeting for which the notice was posted if the public body complies with all other public notice requirements required by this section.

- (c) If a statement or notice is not posted pursuant to subdivision (a) or (b) of this paragraph, shall file a statement with the clerk of the board of supervisors stating where all public notices of their meetings will be posted and shall give additional public notice as is reasonable and practicable as to all meetings.
- 5. SELECTION AND/OR APPOINTMENT OF DISTRICT OFFICERS AND STAFF. At this time, the Board may select or appoint individuals to serve the TTDWID, voluntarily or with such compensation as is determined by the Board as part of its discussion on this item.
 - 5.1. District Manager
 - 5.2. District Clerk
 - 5.3. District Attorney
- 6. ADOPTION OF RULES OF PROCEDURE. At this time, the Board may adopt rules of procedure to govern meetings of the Board of Directors.
- 7. PREPARATION OF FINANCIAL STATEMENT AND ESTIMATE OF EXPENSES (BUDGET) AND SETTING DATE FOR HEARING ON THE DISTRICT'S ANNUAL BUDGET. A.R.S. § 48-954 requires the TTDWID to follow the same budgeting requirements that apply to cities, towns, and counties. A.R.S. § 42-17101 requires the preliminary budget to be prepared on or before the third Monday in July, and A.R.S. § 42-17102 explains what must be included in it.
- 8. DISCUSSION, DIRECTION, AND POSSIBLE ACTION REGARDING SEEKING REIMBURSEMENT FROM NON-ASPOA PROPERTIES LOCATED WITHIN THE JURISDICTIONAL BOUNDARIES OF THE TTDWID FOR THEIR FAIR-SHARE PROPORTION OF COSTS OF FORMATION OF THE TTDWID. TTDWID formation costs have been fronted by ASPOA.
- 9. DISCUSSION, DIRECTION, AND ACTION REGARDING ACQUISITION OF THE WATER SYSTEM ASSETS CURRENTLY OWNED BY THE ALISO SPRINGS PROPERTY OWNERS ASSOCIATION (ASPOA). Concurrently with the circulation of petitions for establishment of the TTDWID, necessary documentation was circulated to and signed by property owners within ASPOA to transfer the water system assets currently owned by ASPOA to the TTDWID.

- 10. DISCUSSION, DIRECTION, AND ACTION REGARDING THE ESTABLISHMENT OF PROPOSED WATER RATES AND FEES AND THE SETTING OF A HEARING FOR THEIR ADOPTION. The TTDWID has statutory authority to establish certain kinds of fees (see A.R.S. § 48-910 for specific information about the types of fees authorized). A hearing must be held prior to the approval of such fees and the Santa Cruz County Board of Supervisors must be notified of the hearing at least ten days in advance. The Board of Supervisors has the authority to be represented at the hearing and to advise the district's governing board (A.R.S. §48-910(C)).
- 11. DISCUSSION, DIRECTION, AND POSSIBLE ACTION REGARDING PURSUIT OF FUNDING FROM WATER INFRASTRUCTURE FINANCE AUTHORITY OF ARIZONA TO CONNECT THE WELL AT 42 ALISO SPRINGS ROAD TO THE EXISTING WATER SYSTEM AND MAKE OTHER WATER IMPROVEMENTS AND UPGRADES.
- 12. DISCUSSION, DIRECTION, AND POSSIBLE ACTION REGARDING CURRENT WATER FACILITY MAINTENANCE AND REPAIR ITEMS.
- 13. DISCUSSION, DIRECTION, AND POSSIBLE ACTION REGARDING THE NON-EXEMPT STATUS OF THE WELL AT 42 ALISO SPRINGS ROAD (WELL NO. 55-574654) AND COMMUNICATIONS RE SAME WITH THE ARIZONA DEPARTMENT OF WATER RESOURCES.
- 14. PUBLIC OFFICIAL OVERVIEW. Board of Directors discussion and training overview regarding Arizona Open Meeting Law, Arizona Public Records Law, and other legal requirements applicable to public officials.
- 15. CALL TO THE PUBLIC. At this time any member of the public is allowed to address the Board of Directors on any issue within the jurisdiction of the TTDWID. Pursuant to the Arizona Open Meeting Law, at the conclusion of Call to the Public, individual members of the Board may respond to criticism made by those who have addressed the Board, and may ask staff to review the matter, or may ask that the matter be placed on a future agenda.
- 16. FUTURE AGENDA ITEMS. At this time, any member of the Board may request that an item be placed on a future TTDWID Board of Directors agenda.
- 17. EXECUTIVE SESSION (IF AND AS REQUIRED). Pursuant to A.R.S. § 38-431.03, the Board of Directors may vote to go into executive session, which will not be open to the public, to discuss certain matters. The Board may ask for discussion or consideration, or consultation with designated TTDWID representatives, or consultation for legal advice with the TTDWID's attorney, concerning any matter listed on this agenda for any of the reasons listed in A.R.S. §38-431.03 (A).


